

CHRIS COX PARTICIPANT REQUIREMENTS

Clinic Overview:

The Chris Cox Horsemanship Clinics (CCHC) take place at the beautiful Diamond Double C Ranch outside Mineral Wells, Texas. The price includes six (6) nights accommodation, meals through out the course of the clinic, a stall with bedding for your horse and six (6) days of invaluable horsemanship instruction from Chris and his qualified instructors.

The course requires a horse that you are comfortable riding at a walk, trot and canter on a loose rein. At times you will be riding outside the arena and on the trail, so please be sure you are comfortable with your horse in these situations.
Note: Green broke horses are not suitable.

If your horse is not suitable or you prefer not to bring your horse, then please feel free to contact our administration with regards to the details of the Diamond Double C Horses-for-Hire package.

Please note, that this is a group clinic, so your skills must meet the minimum requirements, and your horse must be manageable. Although participants can each expect a certain amount of individual assistance as a normal part of the clinic, the group progress will not be compromised to assist under-prepared riders or those with unsuitable horses.

We highly recommend that you review the Chris Cox Instructional Program Part 1 DVD series before attending your first horsemanship clinic. This program will familiarize you with the terminology and with what will be expected of you from Chris and his qualified instructors.

These clinics are physically demanding on both the participant and the horse, so please come prepared. We also ask that you inform us on any physical problems or disabilities that will hinder you or your horse's ability, **prior** to attending the clinic.

Payment Terms:

Due to a specific number of people required for each clinic, we require a minimum deposit of \$1,000 paid upon receipt of our invoice after your application is approved. The final balance will be due **no fewer than 45 days prior** to the clinic start date. You are responsible for calling to make this payment. If you fail to pay your remaining balance when due, we'll assume you have cancelled and you will be subject to the following cancellation provisions.

Cancellation: \$300 of the deposit is non-refundable. The remaining amount paid is refundable only if the spot can be filled by another participant.

Note: All clinic deposits are non-transferable to another person.

Requirements:

- a. You **must** complete and return the Chris Cox Horsemanship Clinic Application and a signed Participant Requirements form in order to be approved for a Chris Cox Horsemanship Clinic.
- b. You **must** be 18 years of age or over to participate in a CCHC clinic.
- c. You **must** supply a copy of a negative Coggins Report (all horses) and Health Certificate (out-of-state horses). **Note: A copy needs to be supplied BEFORE your horse arrives.**
- d. Rope Halter and 13-foot Lead Rope. *Note: this and other items are available for sale at the Diamond Double C Ranch.*
- e. Saddle and Pad.
- f. Bridle/Headstall.
- g. Feed/Hay. *Note: You are responsible for your horse's feed.*
- h. Riding Boots — flat leather soles and proper riding heels are best.
- i. We require that all participants contact the facility ahead of time to inform us of their arrival time.
- j. Clinic check-in time is between 2 and 6 p.m. on the Sunday prior.
- k. Breakfast is at 8 a.m. each morning, lunch at 12 p.m. and dinner is served around 6 or 7 p.m. in the evening.
- l. Clinic hours are between approximately 9 a.m. and 5 p.m. Monday through Friday and 9 a.m. to 12p.m. on Saturday.
- m. **NO** video taping is permitted during any part of the clinic. This includes the use of any type of recording device, including cell phones.
- n. Still photos are allowed.
- o. Dogs are not allowed at a clinic.

Important Facts:

1. Check in with facility staff upon your arrival to receive stable and room allocation.
2. The Lonesome Dove Bunk House consists of room-sharing, four bathrooms, kitchenette and a washer and dryer. Please pack light as space is limited.
3. All meals are served in the main dining facility.
4. Pack "town clothes" as you will be treated to dinner at a local restaurant on at least one (1) occasion.
5. You will need to bring your own toiletries.
6. Diamond Double C Ranch is a DRUG-FREE facility. For the safety of others we reserve the right to evict those suspected of drug use.
7. For safety reasons we do not allow riding on the premises without a staff member present.
8. Designated outdoor smoking areas are provided. Smoking is not allowed in any of the facility buildings.
9. RV/Trailer hookups are available for \$20 per night, electricity only.

Note: Children under 10 years of age may audit for free. All tickets are general admission. We recommend you bring lawn chairs. Accommodation in the Lonesome Dove Bunk House is not provided with the auditor's package; however hook-up facilities are available at the rate of \$20 per day.
